TERMS & CONDITIONS OF SALE

AGREEMENT BETWEEN

Majestic Group Ltd., trading as Majestic Trees hereinafter referred to as 'the Supplier'.

AND '_____',
hereinafter referred to as 'the Customer'.

1) PAYMENT PERIOD

Full payment of due invoices to be paid within thirty (30) days of the invoice date.

2) CANCELLATIONS

All orders cancelled after seven days incur a 20% restocking/cancellation charge. All orders that are to be held longer than 30 days outside of agreed terms will require payment in full and a 10% per month maintenance charge unless other terms are negotiated.

3) INTEREST ON LATE PAYMENT

All overdue amounts will be charged at a rate of 1.5% per month.

4) DISCOUNTS

A two (2)% discount of the invoiced amount will be allowed if full payment is received within ten (10) days of the date of the invoice.

5) NOTIFICATION OF QUERIES AND COMPLAINTS

Notification of queries and/or complaints must be notified to the Supplier verbally or in writing within seven (7) days of receipt of the goods and/or the invoice: whichever is the latter.

6) WARRANTY

There is no warranty by the seller, Majestic Trees, of the plant material we supply unless it is agreed by Majestic Trees that there was inherent disease or pests not observed either before or at delivery. If neither party can agree, an independent arbitrator that is mutually acceptable will rule on liability. At no time will Majestic Trees be responsible for more than the value of the original tree and delivery. We do our utmost to ensure that plants are undamaged, but as we have no control over the plants supplied by us once they have left our hands, we give no warranty, expressed or implied except for that stated above, as to the growth or suitability of the plants to their ultimate location, after acceptance of delivery or collection. Any trees or plant material that is unacceptable must be rejected at the time of delivery or alternative arrangements made with the office. Failure to do so will deem those goods as being accepted by the customer.

7) RETENTION OF TITLE

Title to the invoiced goods will only pass to the Customer, when full payment of the invoice is received. This will apply to all transactions between the parties unless varied in writing by both parties.

8) LAW

In the event of a default of this Agreement, these Terms and Conditions of Sale shall be governed by English law.
